Terms and Conditions

- 1. The Term Loan Instrument is a contract between the applicant and North York (Chinese) Baptist Church, herein referred to as "The Church".
- 2. The applicant must have reached the age of majority (18 year of age) according to the laws of the Province of Ontario.
- 3. Term of deposit is three years or five years from the date of issue.

 Interest rate: taking the current average of the big 5 banks posted GIC rates for 3-years and 5-years term.
- 4. Term Loan holders can elect to waive the interest payment at application or during the term. If interest were selected, a term loan holder must notify the Church of or before November 30 of any year, if they want to forego the interest earned for that year.
- 5. The Term Loan holder must notify the Church of any change in residency status immediately.
- 6. Withholding tax of 25% will be deducted from interest payment for non-residents.
- 7. The Term Loan Instrument is non-transferable.
- 8. The term loan instrument shall ensure to the benefit of and be binding upon the Church and its successors and the holder of the instrument or the heirs, executors, administrators, successors, and assignees of such holders.
- 9. All instruments are denominated in Canadian dollars in increments of five hundred dollars (\$500).
- 10. If a member requires the funds for an emergency, the Church subject to officer approval can allow the term loan to be paid back.

條 款和條件

- 1. 定期貸款工具(以下簡稱定期貸款)為申請人與北約華人浸信會(以下簡稱教會)之間的合約。
- 2. 按安省法例,申請人年齡須在十八歲或以上。
- 3. 存款期限為三年或五年。 利率: 以五大銀行的三年和五年期的GIC利率平均水平為基礎。
- 4. 定期貸款工具持有人可以選擇在申請時或在貸款期內免除利息。如果選擇了利息,貸款人如果想放棄該年所賺取的利息,必須在任何一年的11月30日或之前通知教會。
- 5. 持票人之居留身份或國藉若有任何改變,須即通知教會。
- 6. 如持票人非本國公民或移民,所得利息將依據政府稅例扣除25%。
- 7. 「定期貸款工具」不得轉讓。
- 8. 此定期貸款工具對雙方之繼承者、後嗣、遺產執行人皆有效。
- 9. 貸款工具面額以加幣每單位500元或其倍數計算。
- 10. 如果會友需要緊急資金,經執事會職員批准,教會可以允許償還定期貸款工具。
